St. Petersburg Yacht Club is presenting its 23rd *Annual Christmas Boutique*. The SPYC Christmas Boutique is a 501(c) 3 organization. Participation is limited in each category of retail sales, non-profit groups, artists, and members of SPYC. We are seeking quality and diversity in the participating vendors. The Boutique shopping will be from 1 - 6 PM. Please respond by the deadline of October 30, 2023. We will be limited to 45 spaces and expect them to be sold out before that date, so don't procrastinate, submit your application and check quickly.

Vendor Instructions:

Vendors have a choice of four registration options:

- One draped table and chair for \$80, or
- A 10' X 10' space with one draped table and chairs for \$100, or
- A 10' X 10' space with two draped tables and chairs for \$120, or
- A 10' X 10' space with one draped table and chairs and your own rack for \$120

Note: 10' X 10' spaces are limited and will be assigned on a first come, first served basis according to date the vendor's payment is received at the SPYC.

Vendors are responsible for their own signs, nametags, displays, and method of payment and are responsible for collecting Florida State Sales Tax and reporting & remitting to the Florida Department of Revenue. For additional exposure, each vendor is required to provide a raffle item with a retail value of \$25 or more. Raffle items will be on display and all proceeds from the raffle will benefit SPYC Junior Sailing Program. Simply indicate your raffle item and its value below and bring the item with you to the Boutique on November 28th, 2023.

Set up for the Boutique will begin at 10:00 AM and end at 12:30 PM at the SPYC. You must be checked in by 12 PM. Shopping begins at 1 PM, and concludes at 6 PM. After unloading items, please park at the St. Petersburg Sailing Center or any nearby city parking at your own cost.

Cancellation Policy

The deadline for Vendor cancellation is **November 18th, 2023.** If a written notice of cancelation is received before or on that date Vendor will receive a full refund. No refunds will be made thereafter. In the event a cancellation occurs due to fire, casualty, hurricane, act of war, act of God or any other like emergency, the Vendor will receive a full refund.

Liability

Vendor is held responsible to insure their own exhibit, personnel, display and materials from any damage or loss through theft, fire, accident, or other causes. It is expressly understood and agreed by the Vendor that no claim of any kind will be made against the St. Petersburg Yacht Club for any loss, damage, theft or destruction of goods or exhibit; nor for any injury that may occur to Vendor and their employees while at the SPYC Christmas Boutique. The undersigned does hereby and forever discharge the St. Petersburg Yacht Club and the SPYC Christmas Boutique, of and from all manner of actions, suits, damages, and demands whatsoever in law and equity, from all loss or damage to the undersigned's property, while in possession, supervision or auspices of the St. Petersburg Yacht Club.
